This month's newsletter contains information about the most recent meter installations, plans for road maintenance, and the annual Consumer Confidence Report. METERING PROJECT

Several more meters were installed this spring, bringing the total number of metered connections to nineteen. Two new meters were installed on services that were in arrears to allow for lockouts if necessary. A third meter was installed on a service that was leaking and in need of repair.

Further meter and valve installations will be evaluated in the fall as funding of the capital improvement reserve allows.

ROAD MAINTENANCE

Okanogan County PUD has put the underground power contract out for bid. The winning contractor will be replacing all of the buried power lines in Crumbacher Estates later this year. Once the bid has been awarded, the Board will be contacting them regarding road system improvements.
