PENDING WATER RATE CHANGES

Have you taken the time yet to provide your input on the water rate changes that will soon be adopted? The last newsletter included a questionnaire with various rate changes that could be adopted. The Board is very conscious of the financial impact that these increases will have on our membership, and in order to make the decision that best fits our association, every member should make their opinion heard.

If you wish to participate in the survey, please return them to the Board by June 15th. A decision is anticipated in the June meeting.

Please take a minute of your time and complete the questionnaire. It can be returned by mail, or completed online through the website.

COVENANT REVISIONS

The second important issue for membership consideration is the proposed changes to the covenants. The covenants cannot be altered in any way without the approval of at least 60% of the membership. This makes your input imperative—the document must reflect the majority wishes of the association.

So far, the covenant committee has received only minimal input from the association. While the currently available draft has been assembled with the intention of reflecting the wishes of the membership, there is a great deal of opportunity for further modification. Again, please take just a few minutes to voice your concerns or opinions to a Board member.

Some of the most substantive input has been surrounding the role of the Board in reviewing building plans, enforcing setback requirements, and determining what constitutes "commercial activities" within the association. These covenants are currently in place, but seem to have been inconsistently enforced in the past. Discussion is ongoing about whether such items should be relaxed or dropped entirely from the covenants, or if the Board should become more aggressive in defining and enforcing them.

The covenant committee had previously proposed a review period, followed by a mail-in ballot. Some opposition has been raised to this process, and the

committee will review the process, and consider other alternatives. It has been suggested that one or more neighborhood discussion meetings be facilitated, in order to prompt additional input. If you are interested in seeing a process like this take place, or would like to assist in any way, please contact the covenant committee chairman, Rennie McCormick, at 509-826-8034.
